



38th ANNUAL OLD TIME MUSIC & DANCE 2015 ARTS & CRAFTS APPLICATION

The festival features national grand-championship competitions in old time music, buck dance and clogging, Trail Blazer and Heritage awards, food and impromptu jam sessions. The festival is owned and operated by the non-profit Dave Macon Commission and held at the Cannonsburgh Village Park owned by the City of Murfreesboro. The Dave Macon Days partnership with the City of Murfreesboro. Professional promotion with local and regional print/electronic sources attract an average attendance of 25-30,000. A gate fee of \$5-10 is charged.

All prints and photographs must be fully executed by the exhibitor. Demonstrations are not required. *No buy to resell items.*
