



38th UNCLE DAVE MACON DAY'S FESTIVAL JULY 10- 11- 12, 2015 CONCESSION APPLICATION

Thank you for your interest in the Uncle Dave Macon Days Music & Dance Festival. The 2015 event has new Sunday hours. The event features national grand-championship competitions in old time banjo, buck dance and clogging, Trail Blazer and Heritage awards, arts, crafts, food, storytelling and impromptu jam sessions. The festival is operated by the non-profit Dave Macon Commission, and held at the Cannonsburgh Village Park (owned by the City of Murfreesboro). The Dave Macon Day's partnership with the City of Murfreesboro, WSM Radio and professional media coverage attracts an average attendance of 25-30,000. A gate fee of \$5-10 is charged for each day.

UDMD reserves the right to cancel any contract upon receipt of notice from any fair, festival or other event that the exhibitor/concessionaire has been suspended, expelled from or otherwise penalized for violation of contract terms or rules of venue. I understand that Uncle Dave Macon Days Festival reserves the right to determine placement of any concession.
	I understand that the festival does not carry insurance to cover my personal property and that I store and display my products at my own risk. An insurance certificate listing City of Murfreesboro & Uncle Dave Macon Days as Additional Insured for one-million (\$1,000,000.00) due on acceptance.
	No camping of any type is allowed on the show grounds or greenway.
	I understand that <u>One parking pass</u> is provided for each approved vendor. Additional vehicles may park free at the offsite parking garage. Scheduled shuttles are provided free of charge.
	Empty propane tanks are prohibited. Do not bring empty tanks with you. Fire extinguishers are required.
	I understand that Signage is not to exceed the height of concession exterior wall (trailer, truck or tent). Street sign should not impede foot traffic and should be hung from the unit, or stood within the allowed footage.
	All items sold must be properly and plainly marked with the price of said item. You may not increase or decrease the established and posted price of any item sold under your contract without the prior consent of the Director.
	Will you have employee shift changes? Workers who will depart and/need to return - Passes will be given at the gate to return. Replacement workers names must be provided prior to the event and may enter only at the vendor parking area.
	I understand that NO waste water, grease/oil is to be left behind, poured in any drain , or receptacle not designed for oil recycling, or waste water. Illegal dumping of waste water will result in closure and/or State fine.
	I understand that flashing lights, sirens, loud speakers, music, or roaming with foods are not allowed.
	I understand that I may sell beverages (soft drinks, coffee, tea, root beer) and that <i>no alcoholic</i> beverages are permitted.
	You are responsible for all internal wiring required to operate and for a minimum of 100 feet of adequate sized cable to reach electrical service panels. There is no unauthorized entry of the electric panel box of any kind or, by anyone not authorized by the City of Murfreesboro.
